KEYNOTE SPEAKER

Filling the Cracks with Gold: Loss and Restoration in 2021

Zachary D. Rethorn, PT, DPT

2020 was a year unlike any in our lifetimes. The global COVID-19 pandemic upended life and exposed cracks in our healthcare system and society. But there is good news. We have the opportunity to fill those cracks. Physical therapy professionals can improve the human experience through understanding and addressing social determinants of health in our practices, expanding our reach to patients and communities via telehealth, and leveraging our collective impact through non-clinical opportunities. Attendees will leave with an understanding of three key areas which will impact the PT profession in the future and collaborative opportunities with fellow attendees in these key areas.



Dr. Zachary D. Rethorn is a board-certified orthopedic physical therapist and certified health coach with clinical and research expertise in musculoskeletal pain conditions, physical activity, and health promotion. He earned his undergraduate degree in Exercise Science from Belmont University followed by his DPT degree from the University of Tennessee at Chattanooga. Dr. Rethorn completed a residency in orthopedic physical therapy and is a PhD candidate in health promotion and wellness at Rocky Mountain University of Health Professions where his research focuses on how health professionals promote physical activity with their patients. He is a faculty development resident at Duke University in the Doctor of Physical Therapy Division and owner of Rethorn Physical Therapy and Wellness, a digital physical therapy practice. He has presented at national and international conferences on topics related to orthopedic physical therapy and health promotion.

A1. Portland Shrine - A Resource and Collaborative Partner in Pediatric Orthopedic Care

This presentation will discuss collaborative care for pediatric patients, with Shriners Hospitals for Children – Portland as a local resource. We will discuss a variety of specialty clinical services, such as orthopedics, neuromuscular, spasticity, fracture and sports injury, orthotics and prosthetics, rehabilitation services, and motion analysis to explore how they work together to optimize patient care. We will address patient access to this family centered, coordinated care. We will also review current research and future program development.

From osteoarthritis to focal articular defects, articular cartilage injuries of the knee are a common treatment challenge for physical therapists. B1. Applications of Adapted Mobility in Early Childhood

Patricia Gail Laochinda, PT, DPT, MSPT



Adapted mobility in the form of GoBabyGo cars has gained popularity across the world over the last 14 years. Research indicates the benefits of this early mobility include improvements in socialization, participation, communication, cognition, and self-initiated mobility. In this presentation, benefits and perceived barriers to GoBabyGo cars will be discussed. The Wichita State University GoBabyGo program will be highlighted, including the collaboration between student PTs, engineers, and community mentors. From simple to complex, a variety of GoBabyGo car builds will be delineated, including successes and opportunities for growth and learning.

B2. Exercise in Post Concussion and Considerations for Return to Play

This course will focus on the role of the Physical Therapist in returning an athlete to play after sustaining a concussion. With the recent passing of SB1547 in Oregon, allowing Physical Therapists to clear these athletes back to play, it is more important than ever to analyze the methods we use to evaluate and treat athletes who plan to return to their sport. We will focus on the most recent available evidence to guide clinical decision making and ensure best practice.

B3. Understanding of Disability Outside of Medical Contexts: Increasing Professional Advocacy and Support for Patients

This session will focus on exploring topics that have emerged out of the field of disability studies such as disability identity, disability orientation models. Also, research that revolves around clinicians' attitudes towards disability and potential factors that may influence those attitudes will be discussed. This session will include case studies and will incorporate discussion to expand physical therapists' knowledge of disability studies and relevant research, which will provide an opportunity to demonstrate understanding of the disseminated information.

Being truly "person-centered" means letting go of our own PT priorities and investing in social participation outcomes that are of priority value to the children and families we serve. Come explore the potential of using PROMIS®, Goal Attainment Scaling (GAS), standardized activity quick tests, and other measures that will broaden our impact and enhance the value we can provide families.

This presentation is appropriate for any PT or PTA who has an interest in better serving people who are gender diverse. The lecture will review definitions and terminology related to transgender health and teach strategies for trans-inclusive communication and documentation. Attendees will learn about the transgender and nonbinary experience in the US and specifically in healthcare and in Oregon. The lecturers will present physical therapy considerations for gender-affirming care, including topics such as tucking and binding.
